

## **Minutes**

1) Apologies for Absence and Declarations of Interest in Agenda Items:

There were no apologies for absence and there were no declarations of interest on any agenda items.

2) Minutes of Previous Meeting:

The minutes of the meeting held on 12<sup>th</sup> February 2024 had been circulated to all. NS proposed the minutes be adopted as correct. This was seconded by DF and all members present at the meeting, were in agreement. The Clerk agreed to take the minutes to NS for signing and publish on the Website.

3) Brief recap on consultation and meeting statutory requirements:

AL reported that the response to the Regulation 14 Consultation was very good and all critical Statutory bodies had replied. Over 70 residents had also sent in comments, this was down to the excellent publicity of the event. An overview of the comments suggested there would be no wholescale reform needed to the draft plan, just a few tweaks. AL also reminded the members that although they were duty bound to consider all comments, they were not duty bound to make the amendments suggested.

#### 4) Moving from Pre-Submission (Reg 14) to Submission (Reg15):

- a) <u>Confidentiality and interests</u> AL clarified that although she had seen the original comments from the Statutory bodies, only RL and the Clerk had seen the hand written comments collected from residents. Members were reminded that all comments were to be kept confidential. Residents would be identified by a unique number. Any amendments to the Plan would be managed by the 'Track Changes' facility and then the Plan saved as a different version. Individual commentators would not be replied to; clarification would only be sought if there was doubt or confusion.
- b) Scope of amendments to the Plan, including when consultation is required AL confirmed that there was a very broad scope of amendments suggested. Amendments could be made to the draft Plan but if there were any significant amendments Regulation 14 may have to be undertaken again.
- c) <u>Practical process and indicative timetable</u> AL stated that the 'tried and tested' method of reviewing the comments was to simply plough through the Table. It may take 2 or 3 meetings. The aim was to present it back to Ufford Parish Council at their regular October meeting. Hopefully the review would conclude by the end of September, with a final SG meeting to agree the document see *item* 8 for dates of next meetings.
- d) <u>Parish Council involvement</u> KJ, DF and NS confirmed that the Parish Council was 100% onside, but that some Councillors did wish to see all the comments and the action taken, if any. AL confirmed that that would happen; the PC would see everything apart from the original hand written comments.

The group discussed the recent change of administration at both ESC and Government; AL felt neither were likely to make a big change to the Plan, in fact they may work well with our timings.
